Shareholder Privacy Notice

This Shareholder Privacy Notice (the "Notice") applies to you if you are a current or former registered shareholder of Senior plc. The Notice describes what personal information we collect, how that information is used and what your rights are in relation to this information.

References to "we", "us" or "our" in this Privacy Notice mean Senior plc, a company incorporated under the laws of England and Wales and company number 00282772 with registered address at 59/61 High Street, Rickmansworth, WD3 1RH, United Kingdom.

Data Controller

Senior plc is the data controller responsible for the personal information we collect and process.

What information we may hold about you

We may collect and process the following information about you:

	name and address
	contact details (email address and phone number)
	nationality (if applicable)
	bank account details
	identification documents
J	number of shares held and sold
	dividend payment values and HURN
J	voting instructions
J	Corporate Action election options (if applicable)
	date of birth
J	National Insurance Number and tax information
J	date of death

How we collect the information and why we have it

We have engaged Equiniti Limited and other Equiniti Group entities ("Equiniti") to maintain the Senior plc shareholder register and process shareholders' personal information on our behalf.

Your personal information is collected when you provide it directly to us, to Equiniti or to other third parties engaged to carry out services on our behalf, for example when you provide your details via Equiniti's website.

The personal information we collect is held and processed for the following purposes:

J	to manage your shareholding in Senior plc and keep your record on the shareholder
	register up-to-date;
J	to pay dividends to you;
J	to make shareholder communications and shareholder meeting materials available to
	you, such as the Annual Report and the Notice of Annual General Meeting;
J	to allow you to exercise your rights as a shareholder, such as the right to vote at
	shareholder meetings; and
J	respond to any correspondence you send to Senior plc.

Your personal information is processed

- where it is necessary to fulfil a contract with you;
-) where you have given your consent;
- where it is in our legitimate interests to process your personal data provided these do not prejudice your own rights;
- where we are required to process your personal information to comply with our legal obligations.

With whom we share your information

Your personal information will be shared where there is a legal requirement to do so, for example with regulatory authorities or government bodies. Your information will also be shared with Equiniti, our share registrar, and may be shared with other trusted third parties engaged by us to perform processing activities on our behalf.

If your personal data is transferred outside the European Economic Area ("EEA"), this will be done under legally recognised data transfer mechanisms.

How long we keep your information

We retain your personal information for as long as is necessary to fulfil the purposes for which it was collected. We shall keep your information on the shareholder register while you are a shareholder of Senior plc, and for up to 12 years after you cease to be a shareholder. We may retain your personal information to comply with applicable legislative and regulatory requirements.

Your rights in respect to your personal data

Under Data Protection law, you have rights including:

right to access your personal information

right to ask us to rectify factually inaccurate information we hold about you

right to ask us to erase your personal information (subject to certain exceptions)

right to object to the processing of your personal data

right to ask that we transfer the information you gave us to another party.
